CM2311-02 Declarations of Interest

CM2311-03 To approve the minutes of the meeting held on the 18th October 2023 as a true record.

RESOLVED to approve the minutes from the 18th October meeting as a true and accurate record.

CSO outlined outstanding actions with the exception of those being the subject of agenda items.

CM2311-05 Budget Monitoring Report to 30/09/2023
The RFO outlined key points from the Budget Monitoring Report and directed the attention of councillors to an overspend of £44,000 in relation to Mumbles Skatepark. The RFO explained that there had been an underspend of £43,000 in the previous financial year which will be carried forward as an earmarked reserve for that specific purpose.

RESOLVED the Budget Monitoring Report was accepted.

RECOMMENDED: RFO to arrange a survey on the pavilion and other structures contained within the grounds of Mumbles Bowls Club.

CM2311-06

Budget 2024/25 including presentation by RFO, Paul Beynon

The RFO presented his budget report for the current financial year and issues impacting on the 2024/25 financial year. In particular The RFO stressed the need for any budget proposal forms relating to new expenditure be submitted to him by 1st December 2023. A number of actions for councillors and officers were generated during the discussion which have been set out below.

AGREED: the RFO's report and presentation were accepted. It was agreed that a £5,000 grant in relation to Mumbles Bowls Club be carried over to the 2024/25 financial year.

ACTION: Cllr. Pam Erasmus to establish identify costs connected to Mumbles Skatepark, in particular the cost of a further Skate Jam in 2024.

ACTION: Cllr Sara Keeton to identify traffic calming/road safety options in the vicinity of Whitestone Primary School, through consultations with shop proprietors in the Top Shop Area. Budgeting figures to be obtained.

ACTION: RFO to obtain quotes in relation to fencing surrounding Langland Tennis Court.

ACTION: Following discussion of Cllr Tim Zhou's free five a side football proposal, Cllr Zhou to establish whether Court 4 of Langland Tennis Courts would be a suitable venue.

ACTION: Following the discussion as to whether Court 4 of Langland Tennis Courts would be a suitable venue for five a side football, Cllrs Sara Keeton and Pam Erasmus to provide budgeting costs of carrying out a scoping exercise as to Court 4's suitability.

ACTION: Following the proposal by Cllr Pam Erasmus that a beach wheelchair would be beneficial at Langland to assist lifeguards with people injuring themselves on the beach, both Cllr Pam Erasmus and CSO to research the options available. The wheelchair would be available for rescuing injured persons on the beach and not to provide support for disabled persons. Should the purchase of such a wheelchair be approved other considerations including its storage, having suitably qualified persons to use it and the potential for insurance claims are to be considered at that point.

ACTION: Following the proposal by Cllr Phil Keeton that to RFO by 1st December. a Lego Build-It Scheme be created within MCC area Cllr Phil Keeton to submit a budget proposal form.

ACTION: Following the proposal by Cllr Sara Keeton that a climbing frame be erected in Fairwood Park Cllr Sara Keeton to submit a budget proposal form to RFO by 1st December. The climbing frame would be aimed at older children in the 9 to 12 year age group. In addition Cllr Phil Keeton to explore SCC costings.

ACTION: All Councillors to submit budget proposal forms to RFO by 1st December 2023. Draft committee budgets to be approved at the next committee meeting on 6th December 2023.
