CM2403-03 Mumbles Yacht Club Discussion

The Chair, Cllr Erasmus outlined how she had met representatives from Mumbles Yacht Club (MYC) at The Ostreme Centre on 15th March who had set out their plans to build a new yacht club facility on the seafront opposite their current location. The funding for this new complex would be made through the sale of their existing premises and lottery money.

On 20.3.24 MCC had been provided with an email, detailing the proposals and how initial funding of approximately £12,500 would be necessary to carry preparatory work such as inspections. In the event of MCC providing additional grant money MYC hope to reimburse the amount following the sale of their current premises. The CSO had circulated the information provided by MYC to all MCC staff and councillors and invited them to the next Community & Social Development Committee Meeting on 17th April when a presentation will be made by Kimberley Littlemore who is a member of The MYC Executive.

One grant to MYC of £650 plus VAT has already been approved by Full Council at their March Meeting. A revised grant application by MYC will be considered by The Finance and Compliance Committee on 15th April 2024.

AGREED; whilst it may prove difficult to provide additional funds in the region of £12,500 the committee was agreed in wishing to support MYC in their venture. The CSO will continue to update all members of MCC on developments through liaison with Kimberley Littlemore.
