to whom it may concern, for passing on to the relevant sub committee.

My business - Tides Fine Art Gallery, has evolved to showcase local professional artists, bridging the gap between artists and gallery, so a gallery where the artist takes more ownership of their exhibition and communicates directly with visitors to the gallery and participates fully in exhibiting their work in a commercial setting. Fine Art is inclusive of all media, and I am particularly interested in showcasing some local sculptors work. The space opposite the gallery, Southend Gardens, is a perfect public space where this could work very well. Previously this space has been dominated by local hospitality venues and I believe that it has worked well for them. To have sculpture carefully placed so that it is safe and accessible to visitors alongside hospitality could be lovely, also another feather in Mumbles cap as a tourist destination and wonderful place to either visit or live, It would also be supportive of artists of which there are many in our area and beyond, plus widen further the cultural diversity offered in Mumbles.

In the first instance I have...

- 1. Discussed with a couple of sculptors the space and provision of the area for their work. This has been very well received.
- 2. Posted on social media, including the next door app, and received good feedback and support of doing this.
- 3. Tides is currently working alongside, in collaboration with, 2 directors of The Elysium Gallery in Swansea, an addition of offering sculpture a public stage beyond the realms of a gallery inside space and further afield than Swansea, is supported whole heartedly.
- 4. Ive attempted to contact the Heavens as owners of Mors to enquire if they would have any objections,

and to see if they are assembling their tent again this year in the gardens - as yet there has been no feedback or response. Southend Gardens was occupied by themselves with a select few 2020 and 2021, communication had been selective and this did obviously cause issues. Communication is paramount to all businesses in Mumbles, and we need to act in supportive, collaborative and forward thinking ways if Mumbles is to continue to thrive with small businesses at its core, and attractions that bring tourists and locals in. Art, culture and hospitality should come together to add culture and diversity in Mumbles. this is an excellent time to address this.

5. Health and safety has been looked into. Tim Kelly, Director of Elysium Galleries, who I am working alongside with in Tides, is well practised in covering this aspect and he is very willing to work alongside whoever so that health and safety is supported and implemented completely.

My intention is that the exhibition commences spring into Summer 2022. I look forward to hearing from you very soon.
