CT2409-03 **Minutes of the Previous Meetings of the Committee**

Budget Monitoring Report to 31/07/2024 - RFO, Paul Beynon

Reports attached.

Financial reports prepared by RFO Paul Beynon who had previously distributed the reports to committee members.

The RFO outlined how all the projects were currently within budget with the exception of MumblesFest 2024 which is slightly overspent. However this is offset by income received at The MumblesFest Event together with an anticipated £500 refund from SCC as there was no damage to the field as first suggested.

No issues to be take forward to October Meeting.

No questions relating to the budget reports had been provided either to the CSO or the RFO prior to the meeting, and no questions were raised at the meeting.

Budget 2025/26

The RFO had previously set out at Full Council the importance of a budgeting timetable for the remainder of the financial year, looking ahead through planning at committee meetings and the early submission of budget proposal forms.

Cllr Marshall reminded members that decisions on budgeting issues including budgeting proposal forms needed to be carried out at November's Meeting. Due to the lack of money available in light of The Ostreme Re-Developmentr Programme alternative means of generating money also needed to be considered including external funding and sponsorship.

The RFO informed the committee that any new budget proposal forms, including one for MumblesFest 2025, should additional funding be required, be submitted for October meeting. Following debate in October all budget proposal forms together with other budgetary considerations will need to be recommended at November Meeting.

Essence of Mumbles Update

Cllr O'Neill detailed how the project was now operational, having been launched online. Although enquiries had been made regarding enrolling into the competition, greater public awareness was required particularly through the use of social media.

Cllr Zhou outlined how he had liaised with Swansea and TSD Universities together with Gower College and a number of local charities for the purpose of promoting the competition. Cllr Zhou will next be contacting schools and distributing posters to cafes, doctors' practices, Churches and other key venues.

ACTION: Cllr Zhou to liaise with schools to promote competition through contact with MCC school governors providing input for school newsletters.

ACTION: CSO to provide Cllr Zhou with details of school governors.

ACTION: Cllr Zhou to arrange distribution of posters to suitable establishments within MCC as described above.

Discussion took place over benefits of having a long-term calendar of events, which would allow for preparations to be made including the booking of facilities and costings to be made.

RECOMMENDATION: That subject to budget availability, Full Council approve in principle the proposed calendar of events (previously distributed) and delegate powers to arrange such events to the Culture, Tourism and Communication Committee.

Mumbles Folk and Blues Festival Update

Cllr Marshall provided an update on behalf of Cllr Jarvis. The Autumn of 2025 would be the most appropriate time. Dates of 4th and 11th October 2025 were considered as this would ensure that the event would not clash with the autumn rugby internationals, also the 4th October would coincide with Octoberfest event taking place that weekend.

In terms of budgeting, Swansea Building Society have offered to provide assistance to Cllr Jarvis in terms of potential sponsorship and arranging a fundraising event in June 2025. Although it is hoped that the event will be self-financing contingency plans will need to be considered at November's Committee Meeting.

RECOMMENDATION: That Full Council approve a Mumbles Folk and Blues Festival on Sunday 4th October 2025 with delegated powers to arrange the event being provided to the Culture, Tourism and Communication Committee. Financing the event will be subject to budgetary availability.

ACTION: Cllr Jarvis to consider budget arrangements for the event including the completion of a budget proposal form.

VE 80th Anniversary Celebrations

Claire Anderson had prepared a budget proposal form which had been circulated to committee members prior to the meeting. It was suggested to hold an event to commemorate the 80th anniversary of the Victory in Europe on Thursday 8th May 2025 at The Ostreme Centre. The event will be hosted by Rob Pendry with wartime music being played and afternoon tea being provided. Together with decorations and other ancillary expenditure the overall cost is expected to be in the region of £1,840. Pip Reason also suggested utilising the World War Two Museum off Jersey Marine, Swansea to enhance the event.

RECOMMENDATION: That Full Council approve a VE 80th Anniversary Celebration on Thursday 8th May 2025 at the Ostreme Centre at a cost of up to £2,000 subject to budget availability.

Newsletter

Claire Anderson set out the options of retaining the current system of circulating printed newsletters as opposed to moving towards the letters being digitally circulated. Currently 8,000 newsletters are produced and the cost of printing and distribution through Royal Mail is £4,025.

A discussion ensued over the merits of moving to a digitally circulated newsletter which would include the saving of considerable money for other projects; but concern was raised over elderly residents potentially missing out on information through lack of internet access.

A compromise was suggested that a limited number of newsletter (perhaps a 1,000) be printed off and made available at key locations such as cafes, libraries, doctors surgeries, allowing elderly residents access to them. In addition, newsletters could be made available at Ostreme at events such as Coffee With Friends or advertising through banners, posters or adverts in publications including The Evening Post.

RECOMMENDATION: That Full Council approve the use of a digital newsletter to be used in conjunction with a limited distribution of a printed newsletter.

Halloween Disco for 14-17yrs at CU

Claire Anderson had prepared a budget proposal form which had been circulated to committee members prior to the meeting. Claire outlined that the age group in question was not well catered for within MCC and that this disco would be a 'pilot' for other such events including a Christmas Disco. Funding would be covered through the use of the current underspent budget and the cost of venue, snacks and DJ would amount to £565.

RECOMMENDATION: That Full Council approve a Halloween Disco for 14 to 17 years old at a venue to be confirmed on Tuesday 29th October 2024. The cost of the event will be £565 which will be funded through the underspent budget subject to budget availability.

February Family Fun Days

A discussion took place on amalgamating four separate fun days during the half term of February 2025 into two events, whereby Oystermouth and Newton would share an event and West Cross and the Mayals would similarly share an event. Unlike Easter or Summer Holidays half terms are restricted to just one week making arrangements for multiple events difficult to arrange.

During the discussion it became apparent that responsibility for Fun Days falls within the auspices of The Community and Social Development Committee. No discussion took place on funding these events.

ACTION: The CSO to contact Cllr Ian Scott, the Chair of The Community and Social Development Committee and seek his views on making a recommendation to Full Council, that only two Family Fun Days take place in February's Half Term for the reasons set out above.

Honour of Mumbles

A discussion took place on how best to honour local persons who have made a valuable contribution to the area, particularly those like Margaret Thrush who have volunteered their services for good causes. It was the opinion of the committee that guidance on how to select nominees and honour them should be decided by Full Council.

RECOMMENDATION: That Full Council adopt a policy for honouring local persons within MCC for their notable contribution to the area. The policy would include both a nomination/selection process and the manner in which the honour should be bestowed.
