# Budget 2025/26

The Chair, Cllr Marshall confirmed that MCC's budget for projects in the forthcoming financial year would be constrained due to the financial commitment to the development of The Ostreme Cenre.

During the discussion that followed it was reiterated that MCC had committed £125,000 for the financial year 2025/26 as part of the £250.000 earmarked for the Ostreme Re-development.

Other areas of discussion included the wish to increase the grant budget and for a Halloween Event to take place in West Cross in 2025.

Further to his e-mail, The CSO reminded all councillors of the need for budget proposal forms to be submitted before 31.10.24.

**ACTION:** Cllr Townsend Jones to submit a budget proposal form to RFO by 31.10.24 in relation to increasing the grant budget to £40,000.

**ACTION:** Cllr Sara Keeton to liaise with Cllr Angela O'Connor, the Chair of The Culture, Tourism & Communication Committee over holding a Halloween Event in West Cross in 2025.

**RESOLVED** to submit budget proposal forms for projects to RFO before 31<sup>st</sup> October 2024.
