**FI2411-06      Budget 2025/26**

The RFO outlined the draft budget spreadsheet to Committee and each budget line was discussed in detail including the new budget proposal.

**FI2411-07      Policy Update**

The Clerk set out how she had circulated three policy documents for the perusal of councillors, namely, A Safeguarding Policy, A Pay Policy and A Terms and Conditions of Hire for Oxtreme Policy. The Clerk had received feedback and stated that a resolution in relation to the policies was urgently required. It was proposed to scrutinise the documents at the Policy Committee within the next two weeks, thereby allowing Full Council to consider any recommendation at The December Full Council Meeting.

The Chair, Cllr Marshall, a member of the policy committee is unavailable during the proposed timescale and Cllr Erasmus agreed to contribute at the committee in his absence.

**Mumbles Bowls Club Grant Application**

Grant Application for £2,242.62 to contribute towards the maintenance of the playing surface at Mumbles Bowling Green.

A discussion ensued in relation to the merits of the application, in particular why Mumbles Bowls Club required the grant when they have £10,000 in their bank reserves. Also concerns were raised over the member application process, Councillors believed that applicants had been declined due to the waiting list being full with no apparent opportunity for an additional team being catered for.

**RESOLVED:** The application was deferred until the December Meeting pending enquiries from the applicant in relation to the need for funding and further details on the current application process.

**Upper Norton Field Allotment Association Grant Application**

Grant Application for £1,836 to contribute towards the completion of boundary fencing along the eastern perimeter of the allotments.

Cllr Townsend Jones who had declared an interest in this agenda item at the outset of the meeting gave a brief overview of the application. This centred around safety concerns which included a beehive on the premises. Cllr Townsend Jones then left the meeting at 7.20pm returning at 7.23pm after the discussion and voting.

During the discussion Councillors noted that financial contributions had been made by Welsh Government and The Co-Operative. The application related to a good local cause and match funding had been achieved.

**RECOMMENDED** that a grant of £1,836 be made to The Upper Norton Allotment Association, towards completion of a boundary fence from **Budget FC1**
