**FI2502-06 Sunshine Lotus Yoga Grant Application**

Grant Application for £5,000 to support yoga within the community through Yoga 4 Health

**FI2502-07 Cardiac Risk in the Young (CRY) Grant Application**

Grant Application for £5,000 to contribute towards the screening of 100 young persons aged between 14 and 35 in relation to identifying heart-related issues.

The lack of a constitution was again highlighted during the discussion on this application together with enquiries needing to be made with Bishopston Community Council due to residents from that area benefiting from the screening.
